Open to all U.S. artists and craftsmen. All art must be original; all crafts hand-crafted. See the section on Acceptability Policy for details. We will jury on the morning of opening day to assure ourselves that items follow our guidelines. We reserve the right to disqualify work. No dealers, agents or representatives will be permitted. If you would like to have your items juried prior to the event to ensure they are acceptable, you may send or email photos and a description to the addresses listed below.

SPECIAL NOTES

- ⊙ Vendors provide their own display booths
- ⊙ Canopies will be allowed (must be anchored with sand bags) if they do not interfere with traffic
- ⊙ Vendors provide funds for change as there are no banking facilities in Mackay on weekends
- ⊙ Each vendor must complete Form ST-124, Idaho Sales Tax Declaration, Promoter-Sponsored Event. We will send the form with your acceptance notification.
- ⊙ We request that you remain open until closing hour of each day. No sales prior to 10 a.m.
- ⊙ A watchman will patrol Saturday night. However, the Black Daisy Committee or the City of Mackay will not be responsible for any lost, stolen or damaged items.
- ⊙ Parking permits and a map will be in your Vendor Packet when you check in. Please bring your vehicle license number to check in for your parking permit.
- ⊙ After picking up your Vendor Packet, you may unload and set up Saturday morning starting at 6:00 a.m. and must be ready by 9:30 a.m. ALL vehicles MUST be removed from the booth area after 9:30 a.m. on Fair days. No vehicles or trailers are allowed on the ground area during the Fair.
- ⊙ NO DOGS will be allowed except SERVICE DOGS on the grounds or in vendor booths. NO BICYCLES are allowed on the grounds. NO EXCEPTIONS. We appreciate your cooperation with enforcement of these rules.
- ⊙ No camping is allowed within the city limits except where designated

We will try to accommodate any special needs you might have, however we need to be made aware of those needs prior to July 1, 2009.

ACCEPTABILITY POLICIES

The Black Daisy Committee is committed to promoting individual creativity by providing a pleasurable sales atmosphere at our Fair. We ask that all items for sale be the work of the registrant. Craft items must be hand-crafted, not merely assembled from manufactured parts. Art work may include prints of original paintings, photographic works and multiple castings from original artist-created molds.

Jewelry: We allow only hand-mounted, hand-designed and handmade items, hand polished rocks allowed. **Please NO factory made items.** This will be enforced. Violations will result in a request to stop sales and/or denial of future fair admission.

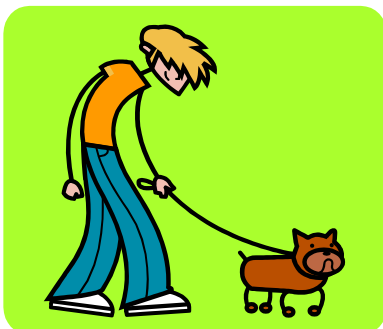
Clothing: All clothing items must be handmade, hand-painted, hand-screened or hand-stenciled. **NO commercial printing, even of original designs, will be permitted;** the Black Daisy Committee has reserved the right to sell their commercially printed original design clothing items in the Black Daisy booth

Food: Lost River Valley residents and/or organizations will have priority for food booths on a paid, first-come basis until April 1st. As food booths are limited we will not duplicate main item foods such as hot dogs, hamburgers, etc. **NO BEER ALLOWED.** Side items such as chips, etc. may be sold at any food booth. Once your booth has been accepted and your menu approved, **NO** changes will be allowed. Variety is beneficial to both vendors and patrons! Food vendors are required to supply a good-quality, heavy-duty electrical cord that will meet their amperage needs and a fire extinguisher. District 7 State Health Department requires licenses for food booths selling foods containing meat and/or milk products. Foods sold as a craft (vinegars, jellies, mixes, or mustards, etc.) should apply for a booth outside of the food booth area

NOTE: The Lost River Valley is considered from Butte City to Willow Creek Summit. A resident is anyone who lives in the Lost River Valley at least six (6) months a year.

NO DOGS OR BICYCLES

NO DOGS except service dogs OR BICYCLES WILL BE ALLOWED ON THE GROUNDS OR IN THE VENDOR BOOTHS!!



Violations: The Black Daisy Committee reserves the right to ask anyone who chooses to violate any of these policies to cease. Continued violations will be grounds for a request to leave and the violator's name will be dropped from the mailing list for future fairs.
